## **MEN'S LEAGUE - DIVISION III/ First Half Schedule Cont.....**

The Men's League will consist of a six team Division II and a six team Division III. Each Division will function as a separate league, with separate Playoffs and Championships.

Each Division will play two halves. The first half in each Division will consist of fifteen games (three games against each Division team ). The second round will consist of eleven games (one round of inter-Division games and one round of intra Division games). The league reserves the right to change the second half to ten games (two games against each Division team) if first half play shows that inter-Division play would not be competitively appropriate.

Four teams from each Division will qualify for the Playoffs - see league rules for qualification, tie-breaker, and scheduling information.

All Star Night and the Hall of Fame Induction Ceremony will take place on Saturday, July 12. Details will be finalized and distributed as the season progresses.
